### Notice of Revision of Dividend Forecast for the Fiscal Year Ending December 31, 2022

Broadleaf Co., Ltd. (“the Company”) hereby announces that, at the meeting of the Board of Directors held today, it has adopted a resolution to revise the dividend forecast for the fiscal year ending December 31, 2022, announced on February 9, 2022, as follows.

※ The year-end dividend for the fiscal year ending December 31, 2022 is scheduled to be discussed as a proposal for the 14th Annual General Meeting of Shareholders to be held in March 2023.

#### 2. Reason for the revision

The Company regards the return of profits to shareholders as an important management issue. Its basic policy is to distribute profits in accordance with business results while retaining the surplus required for business development and maintenance of financial soundness to increase corporate value. Interim dividend year-end dividend for the fiscal year ending December 31, 2022 were undecided, but based on the dividend policy, the Company has set an annual dividend forecast of 1 yen per share, taking into account the performance trends and financial conditions of the current fiscal year.
